Holders of other PCs issued by SGA Associate & Ordinary local clubs will have to go through a Golf Rules and Etiquette Workshop to enjoy full membership benefits. PCs issued by foreign entities are not accepted.
 - d. **Once payment is made, the membership and its privileges are non-refundable and non-transferable.**
 - e. For **Ordinary/Senior/Junior Membership:**
 - i) Members must have at least a PC issued by Star Golf Academy/ MGK Academy to golf in Orchid Country Club (OCC) during weekdays (Monday to Friday) only. Holders of other PCs issued by SGA Associate & Ordinary local clubs who have gone through the Golf Rules and Etiquette workshop at Star Golf Academy/ MGK Academy will enjoy this benefit.
 - ii) Members with a valid USGA-recognized handicap card are eligible to golf in OCC during weekdays and weekends.
 - iii) Members are required to submit a copy of the accepted PC and/or USGA-recognized handicap card for validation by My Golf Kaki before they are eligible to golf in OCC during the stipulated days.
 - iv) Golf insurance is included under membership
 - f. For **Associate Membership:**
 - i) Members are required to submit a valid handicap card issued by local or foreign golf clubs associated or affiliated with the United States Golf Association (USGA).
 - ii) Upon validation by My Golf Kaki, members holding on to a valid handicap card are eligible to golf in OCC during weekdays and weekends. Members are responsible to ensure the handicap card is valid throughout My Golf Kaki membership term, to enjoy full membership benefits.
 - iii) Ensure you have valid golf insurance before playing
 - g. As a registered golf member, I agree to undertake the following:
 - i) To use OCC Corporate Union Golf Card wholly & only in accordance with the conditions for the use of Corporate Union Golf; golf passes are strictly not transferable and must be used by members only.
